# LOUISIANA NENA CHAPTER MEETING MINUTES APRIL 20, 2021 NATCHITOCHES, LA

## **Secretary/Treasurer's Report**

#### Financial

## **New Business**

Committee Reports: Louisiana Next Generation 9-1-1 Sub-Committee

Richard McGuire reported that the Next Generation 9-1-1 Sub-Committee has completed a draft version of the Next Generation 9-1-1 Transition Plan. Mr. McGuire thanked everyone who participated in the drafting of the plan. President Sean Spansel then thanked Richard for all the work he has put in to developing and drafting the Next Generation 9-1-1 Transition Plan.

Mr. McGuire advised that the draft version of the Next Generation 9-1-1 Transition Plan will be presented and up for adoption at the 9-1-1 Director's Consortium meeting that is taking place after the conclusion of the Louisiana Chapter of NENA meeting. Mr. McGuire then advised there are two different approaches that the Next Generation 9-1-1 Sub-Committee is looking to take. The first would be to follow exactly what is in the plan which consist of looking and building out the plan to meet the requirements for the grant program for federal funding. Mr. McGuire advised the other option would be to have a small working group with attorneys to start exploring how we can go out for an RFP to cover all parishes in the state so that we can have a joint purchase. Discussion followed.

Linda Lavergne reported that the Symposium will be postponed until April 2022. The Symposium will still be held in Marksville at the Paragon Casino Resort. Ms. Lavergne advised there are still 28 vendors and 198 attendees registered. Ms. Lavergne asked that if anyone has any ideas for entertainment, training or potential speakers to contact any member of the Symposium Committee.
